[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

BOND TO BE SET AT FIRST APPEARANCE

Probable Cause does exist that on 14 March, 2014, Jack Donald Adair, III, did commit the offense of Armed Burglary, per Florida State Statute 810.02.2b, two counts of Larceny of a Firearm, per Florida State Statute 812.014.2c5, and Criminal Mischief, per Florida State Statute 806.13.1b2.

Per a Sworn Voluntary Statement given by an impartial witness, Adair did describe how he illegally entered into the house by breaking the glass on the front door and, once inside, stealing the two firearms and the prescription pills that are listed in this case. This was disclosed to the witness within hours of the burglary of 306 Steele Church Road, Defuniak Springs, Florida and left no doubt to the witness that Adair committed the burglary and theft due to his knowledge of the crime scene and having the property that was stolen in his possession. The witness, without having ever

been to the scene of the crime or the pictures of the crime scene, was able to describe the elements of the crime based on what Adair stated.

This did occur in Walton County, Florida.

A supplement to my previous probable cause to the affect that on the date of 14 March, 2014, Jack Donald Adair, III, did state to an impartial witness that he did commit the burglary of 306 Steele Church Road, Defuniak Springs, Florida and steel two firearms.

On 14 March, 2014, after disclosing details of the crime to the witness, Adair did sell one of the firearms to Marvin Sparks, the manager of Pawn Plus II in Defuniak Springs, Florida.
