[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 4/29/14 Heith M. Fountain drove to the Lowe's Home Improvement Store located on Business Park Road in DeFuniak Springs, Florida with the intent to steal property belonging to this store. When Mr. Fountain arrived, Mr. Fountain walked into the store briefly and then exited the store. When Mr. Fountain exited the store, he took possession of a Troy Bilt pressure washer valued at \$359.00 from the front sidewalk of the store and loaded it into the bed of a pickup truck. Sergeant Dozier observed Mr. Fountain loading the pressure washer into the bed of a white pickup. A traffic stop was conducted on Mr. Fountain at the intersection of Business Park Road and U.S. Highway 331 South. Mr. Fountain was not able to produce a receipt for purchasing the pressure washer. A statement was obtained from the assistant manager at Lowe's which stated Mr. Fountain did not purchase the pressure washer nor have permission to remove the pressure washer from the business. Later during a post Miranda interview, Mr. Fountain admitted to stealing the pressure washer from the store. This criminal offense, Grand Theft, is in violation of Florida Statute 812.014 (2)(C).

This criminal act and arrest took place in Walton County, Florida.
