[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On December 21st, 2015 I was notified of an investigation pertaining to a foster parent at the Children In Crisis Facility, 1000 Lukes Way, Fort Walton Beach, Florida (Okaloosa County), had molested a child in his care. The defendant, Michael Joseph Hellen, was arrested for molesting a [REDACTED] year old female and through that investigation it was learned that the [REDACTED] year old victim in this investigation was also molested by M. Hellen. The [REDACTED] year old victim disclosed that M. Hellen had touched her on her breast, under her bra, with his hands. The victim described the touching as "tickling" and stated that the touching occurred at least twice in the morning before school.

The victim stated that M. Hellen was [REDACTED] start "tickling" her. The touching went from over the clothing to under her shirt and bra on her breast. The victim stated that when M. Hellen touched her in the bedroom he would shut the room door. The victim stated that during one of the touching incidents someone opened the room door causing M. Hellen to jump back away from the victim and act like nothing had happened.

In the original investigation (Case 15-15593) M. Hellen's wife, Susan "Kim" Hellen, provided a sworn affidavit of complaint stating that her husband apologized to the [REDACTED] year old victims after he had touched them. M. Hellen even admitted to his wife that he touched both female victims.

Based on the information obtained I have reason to believe and do believe the defendant, Michael Joseph Hellen, did violate F.S.S. 800.04 (5)(c)(2) Lewd or Lascivious-Molestation of victim 12 and older. This offense did occur in
