## **OCSO TRAFFIC STOP NETS METH, HEROIN, AND COCAINE**

An Okaloosa County Sheriff's Deputy who stopped a suspicious car west of Mary Esther last night discovered heroin, methamphetamine, and powder cocaine inside.

Two people have been arrested. The Deputy conducted a citizen contact on Creekwood Road around 6:30 Wednesday night.

The driver of the car, 25-year old Jeremy Scott Buckland of Meadow Court in Fort Walton Beach, turned out to be operating it without a valid driver's license and has two prior convictions for driving with a license that had been suspended or revoked.

When the car was being inventoried prior to being towed, the deputy found drugs and paraphernalia in a glove box near the steering wheel. In the back seat was also a bag containing scales, weights, a cut straw and plastic baggies.

Deputies say Buckland admitted selling drugs but says he doesn't use them.

Before the car was towed the passenger, 42-year old Cassandre Prinzo of Mayflower Avenue in Fort Walton Beach, was asked if she wanted her purse out of the floorboard. She told the deputy the purse was not hers and that it belonged to Buckland's girlfriend. Inside he found metal spoons with narcotics residue, glass pipes, two small bags of cocaine and a small bag of meth along with a container of prescription drugs. The purse also contained a notebook belonging to Prinzo.

Buckland said he sold Prinzo the cocaine in her purse.

Buckland is charged with driving with a suspended license, possession of heroin with intent to sell, sale of cocaine, possession of methamphetamine with intent to sell, and possession of marijuana with intent to sell.

Prinzo is charged with possession of a controlled substance without a prescription, possession of cocaine, and possession of drug paraphernalia.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 6/1/16, approximately, 1838 hrs, the Defendant, Cassandre Prinzo, did violate Florida State Statute 893.13.6a Control Substance Without Prescription, Florida State Statute 893.13.6a Possession of Cocaine, and Florida State Statute 893.147.1 Possession of Drug Paraphernalia.

A citizen contact was made on the above date and time with the defendant and codefendant, Jeremy Buckland. I viewed the defendant exit the front passenger seat of the vehicle bearing FL #WN23W and the codefendant exit the driver side. The defendant and codefendant freely provided their names and a NCIC/FICI check was conducted. It was

determined the codedefendant knowingly was operating a motor vehicle without a valid drivers licence. The codedefendant was placed under arrest and the next rotation wrecker was en route. During the tow inventory of the vehicle the defendant was asked if she wanted her purse in the passenger seat floor board. She advised the purse was not hers. Located inside of the purse were the following, two metal spoons with narcotic residue, two glass pipes with narcotic residue, two small bags with cocaine, one small bag with methamphetamine, and a small purple container holding three prescription drugs. Using drugs.com the prescription drugs were identified as three Diazepam, eight Alprazolam, one Acetaminophen and Hydrocodone. The cocaine and methamphetamine were field tested and rendered a presumptive positive test for those narcotics.

Post Miranda, the defendant advised the purse no longer belonged to her, she sold it to the codedefendant's girlfriend. Although she sold the purse, property of the defendant's was located inside which she claimed was hers such as a cat note book. There was also a necklace matching the jewelry the defendant was wearing. She advised her father makes the jewelry and she gives it away to her friends.

There is reason to believe and your affiant does believe the Defendant, Cassandre Prinzo, did violate Florida State Statute 893.13.6a Control Substance Without Prescription, Florida State Statute 893.13.6a Possession of Cocaine, and Florida State Statute 893.147.1 Possession of Drug Paraphernalia.



[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 6/1/16, approximately, 1838 hrs, the Defendant, Jeremy Buckland, did violate Florida State Statute 322.34.2c DWLSR 3rd conviction, Florida State Statute 893.13.1a1 Possession of Heroin with Intent to Sell, Florida State Statute 893.13.1a1 Sell of Cocaine, Florida State Statute 893.13.1a1 Possession of Methamphetamine With Intent to Sell, and Florida State Statute 893.13.1a2 Possession of Marijuana with Intent to Sell.

On the above date and time I witness the defendant, Jeremy Buckland, and codefendant, Cassandre Prinzo in a gold Buick bearing Florida Tag WN23W. The defendant was operating the vehicle at the intersection of Skylark Dr and Happiness Rd. Mary Esther, Florida. I made contact with the defendant and codefendant at the 715 Creekwood Rd. Mary Esther, Florida. I viewed the defendant exit the driver seat and codefendant exit the front passenger seat of a gold Buick bearing FL #WN23W. The defendant and codefendant freely provided their names and a NCIC/FICI check was conducted. The defendant advised his licence was suspended, but his girlfriend was supposed to pay the ticket. OCSO dispatch confirmed the defendant's license was suspended. The defendant's License was suspended on 12/26/2012 and he has 2 previous DWLSR convictions.

The defendant was placed under arrest and the next rotation wrecker was en route. During an inventory of the vehicle for the tow sheet, several narcotics and drug paraphernalia were located in a small glove box near the steering wheel. The white crystal like substance, brown dust, and green leafy substance where field tested. The white crystal rendered a presumptive positive test for Methamphetamine. The brown dust rendered a presumptive positive test for Heroin. The green leafy substance a presumptive positive test for THC. Two unused glass pipes commonly used with narcotic use were located along with a glass pipe with marijuana residue. In the back seat of the vehicle was a small green bag which contained small plastic bags, two scales, two weights, a cut red straw, and two note books used to keep a log of possible sales.

Post Miranda, the defendant advised he did not use narcotics. He stated the narcotics I found inside of the vehicle were intended to be sold. The defendant also added he provided the codefendant two small bags of cocaine which were discovered in her purse.

There is reason to believe and your affiant does believe the Defendant, Jeremy Buckland, did violate Florida State Statute 322.34.2c DWLSR 3rd conviction, Florida State Statute 893.13.1a1 Possession of Heroin with Intent to Sell, Florida State Statute 893.13.1a1 Sell of Cocaine, Florida State Statute 893.13.1a1 Possession of Methamphetamine With Intent to Sell, and Florida State Statute 893.13.1a2 Possession of Marijuana with Intent to Sell.
