BAKER MAN CHARGED WITH TRAFFICKING IN METH



A Baker man faces a trio of felony charges and two misdemeanors following the execution of a narcotics search warrant at his home.

Arriving deputies found 36-year old John Martin Elmore of 1551 Perry Smith Road in a shed on the property May 27th.

Elmore identified the location of crystal methamphetamine inside the shed and inside a book bag in his vehicle. He also admitted to selling it on a regular basis.

The Okaloosa County Sheriff's Office Narcotics Unit turned up approximately 100 grams of crystal meth along with tablets of ecstasy, jeweler's bags, and a digital scale.

They also located a loaded Glock semi-automatic handgun at the home.

Elmore has been charged with trafficking methamphetamine, possession of a firearm by a convicted felon, possession of a hallucinogen with intent to distribute, felony violation of probation, and possession of drug paraphernalia.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On May 27, 2016, members of the Okaloosa County Sheriff's Office Narcotics Unit executed a narcotics search warrant at 1551 Perry Smith Road, Baker, Florida. The suspect of that search warrant was identified as the DEFENDANT, John Elmore.

During the execution of the search warrant, the DEEFNDANT was located in the shed behind the residence.

Post Miranda, the DEFENDANT admitted to being in possession of approximately four (4) ounces of crystal methamphetamine and a firearm. The DEFENDANT identified two locations in which the crystal methamphetamine was stored. Those locations were inside of the shed the DEFENDANT was located in and inside of a book bag inside of the DEFENDANT's vehicle. The DEFENDANT further admitted to selling crystal methamphetamine on a regular basis.

During a search of the shed, Investigators located approximately 3.5 ounces (100 grams) of crystal methamphetamine. This item field tested presumptive positive for methamphetamine.

During a search of the DEFENDANT's vehicle, Investigators located approximately 1.7 ounces (48 grams) of crystal methamphetamine, approximately thirty tablets (8 grams) of ecstasy, jeweler's bags, and a digital scale. It should be noted that 36 grams of the crystal methamphetamine was separated into 9 separate bags that weighed approximately four (4) grams each, which was consistent with distribution. These items field tested field tested presumptive positive for methamphetamine and ecstasy.

During a search of the residence, Investigators located a Glock Model 27 semi-automatic handgun containing eight (8) rounds of .40 ammunition.

Search incident to arrest, the DEFENDANT was found to be in possession of a glass methamphetamine smoking pipe. This item field tested presumptive positive for methamphetamine.

A criminal history was requested on the DEFENDANT. The DEFENDANT's criminal history indicated on October 21, 2015, the DEFENDANT was convicted of a felony offense and he was placed on felony probation.

There is probable cause to believe and your AFFIANT does believe, John ELMORE knowingly violated Florida State Statutes 893.135.1f1; Trafficking methamphetamine, 790.23.1a; Possession of a firearm by convicted felon, 893.13.7a4; Possession of a hallucinogen with intent to distribute, 948.06; Felony violation of probation, and 893.147.1; Possession of drug paraphernalia. This incident did occur within Okaloosa County, Florida, where your AFFIANT is a sworn Law Enforcement Officer.
