On February 19, 2016 at approximately 1700 hours, the above named defendant did commit the offenses of Retail Theft in violation of, F.S.S. 812.015 and Narcotic Equipment-Possess Drug Paraphernalia F.S.S. 893.147, when she entered 6 Brother's Thrifty Foods and was observed by the complainant filling her purse with 26 sperate items with a total value of \$98.24. Upon contact by Law Enforcement and a search of the defendant's purse, a used drug smoking pipe was found.

These offense are evidenced by a sworn Affidavit of Complaint provided by the complainant, Hollie Schumpert, 6 Brother's Thrifty Foods employee, in which she stated that on February 19, 2016, at approximately 1150 hours, the defendant entered the store and filled her purse with hair products, but did not realize she had stolen anything until reviewing video footage after the defendant left the store. Schumpert stated that at approximately 1700 hours, the defendant returned and was observed filling her purse with hair products again along with snack foods and a single can of Budweiser beer. Schumpert stated that her manager stopped the defendant and located the stolen items in her purse after the final point of sale. Upon arrival of Law Enforcement a search of the defendant's purse revealed a used drug smoking pipe along with the stolen items.

Physical evidence also evidences the offense of Retail Theft by in store video and the items located in the defendant's purse. A sales receipt and the used drug pipe were entered into evidence.

The Defendant was advised of her Miranda Rights and verbally admitted to taking the items and claimed ownership of the drug paraphernalia.

These offenses did occur in Okaloosa County, within the city limits of Crestview, Florida where I am a sworn Law Enforcement Officer.
