CHARGES: DUI Manslaughter; No Valid Driver's License

NARRATIVE:
 Vehicle 01 was traveling west on US90. Vehicle 02 (Motorcycle) was traveling east on US90 approaching V01. As the two vehicles neared each other, V01 traveled into the oposite lane of travel striking V02 head-on. V01 continued another 500 feet beyond the initial point of impact before coming to a final rest in the middle of the roadway. Vehicle 2 and driver came to a final rest southeast of the initial point of impact on the south shoulder of the roadway. Driver 2 expired at the scene.

 The driver of V01 was transported to North Okaloosa Medical Center. He was released at 3:40 am and immediately placed under arrest for DUI manslaughter and additional charges.
