ADDENDUM OF PROBABLE CAUSE

The above named defendant did commit the offenses of Criminal Mischief Damage Church Greater than \$200 in violation of F.S.S. 806.13(2), and Resisting Officer Without Violence in violation of F.S.S. 843.02 when he entered a church and began damaging equipment in the sanctuary, as well as in offices located inside the church, then refusing to provide his complete identification to law enforcement on scene. The above named defendant also continued to stand and walk towards officers while detained in handcuffs and place in a chair.

On 02/05/2016, at approximately 1200hrs, I received a call from another officer who was on scene at 100 Duggan Ave. and had the above named defendant detained. I was informed the above named defendant entered the church and began damaging audio equipment in the sanctuary. Law enforcement was contacted by staff at the church who advised they witnessed the incident and requested law enforcement assistance.

After my arrival, the pastor of the church advised his office was also damaged. I asked the above named defendant why he "Did all that," which he advised because he was "Thirsty." While on scene the above named defendant continued to stand and walk towards me and other officers on scene after he was told repeatedly to stay seated. I made contact with a witness on scene who advised he brought the above named defendant to the church that morning and observed him starting to get upset. The above named defendant was transported from the scene at this time by other officers. The witness advised he tried getting the above named defendant help him with work he was doing in the church, at which time the above named defendant walked away into the sanctuary. The witness stated he heard noises in the sanctuary, at which time the above named defendant began kicking the stage. The witness advised moments later the above named defendant began knocking over lights in the sanctuary. The witness stated when he and another witness walked women who were on scene from the area, he heard noises coming from where the offices were.

**ADDENDUM OF PROBABLE CAUSE**

After speaking with the pastor, who was the victim, and the witness, I walked into the sanctuary and observed wires which were pulled from their outlets in the stage and several chairs knocked over. I then walked into the offices and observed a large amount of damage. The walls were damaged with holes, a mirror was damaged, a couch was flipped over, several items were on the floor, and a refrigerator door was removed from the unit. I photographed all damages and collected statements from the victim, and both witnesses. I could not gather a verbal statement from the above named defendant because he refused to answer me with straight forward answers. The estimated amount of damage is approximately 2,000.00.

This is evidenced by the damages I observed in the church as well as the statements provided by the witnesses and victim.

This incident did occur within the city limits of Crestview, county of Okaloosa, State of Florida.
