### ADDENDUM OF PROBABLE CAUSE

I have reason to believe and do believe the above named Defendant did commit the offense of Aggravated Battery (DOMV) - Pregnant Victim on 02/02/2016. This is evidenced by the following.

The Defendant and the Victim, Brittany Sudal, are in a dating relationship. The Victim is 9 weeks pregnant with the Defendant's child. The Victim and Defendant both have knowledge of the pregnancy.

On 02/02/2016, an Okaloosa County Deputy initially responded to 1602 E James Lee and spoke to the involved parties. The Deputy stated he determined the incident occurred as the couple was driving in the area of Twin Hill Park, which is within the city limits of Crestview.

On 02/02/2016 the Defendant and Victim engaged in a verbal altercation while driving in the vicinity of E. James Lee Blvd. During the argument, the Defendant struck the Victim in the stomach. The Defendant then called his mother and stated "he just killed the baby". The Victim was not injured and declined medical attention. The Victim completed a Sworn Affidavit of Complaint. The Defendant departed the scene prior to law enforcement arrival.

On 02/05/2016, the Defendant and Victim arrived at 201 Stillwell Blvd, the Crestview Police Department, to "drop charges". The Defendant and Victim were present together in the lobby of the police department. I again confirmed with the Victim that she was punched in the stomach by the Defendant and asked her if she wanted to drop charges, or if she wanted to recant her statement that she was punched in the stomach. The Victim again stated she was punched in the stomach.

I then asked the Defendant if the Victim's statement was accurate about him punching her in the stomach. The Defendant hung his head and stated "I did". The Defendant then completed a post Miranda statement. The Defendant stated a verbal altercation occurred, but would not state that he punched her. I swore the Defendant to his verbal statements. The Defendant was detained in handcuffs. I allowed the Victim and Defendant to speak prior to transport. The Defendant told the Victim he was a horrible person for what he did.

This offense did occur within the city limits of Crestview, Okaloosa County, Florida.
