ADDENDUM OF PROBABLE CAUSE

I have reason to believe, and do believe the above named defendant, Carlton Cletis McClellan, did knowingly and unlawfully commit the offense of Battery (Touch or Strike) (DOMV) in violation of Florida State Statute 784.03(1A1).

This offense is also evidenced by sworn statements provided to this officer by the victim, I n. After I spoke with Walker I asked if what Walker told me was the truth and she nodded her head and stated "yes sir." declined to make a statement to me but when I asked why Cariton struck her she stated, "Because he's Carlton." also stated Carlton had been arrested "27 times" in the past for striking her.

Furthermore, this offense is evidenced by physical injuries I observed on I sperson. While speaking with I observed a large bruise on her right forearm area, swelling on her left cheek and slight redness under her left eye.

Based on the facts detailed above I have reason to believe, and do believe Carlton Cletis McClellan did knowingly and unlawfully strike I I, with an open hand on the left side of her face and also placed his hands around her neck against her will and without her consent in direct violation of Florida State Statute 784.03(1A).

This offense did occur within the city limits of Crestview, Okaloosa County, Florida.
